### **FIRST COUNT**

THE GRAND JURY OF THE COUNTY OF ERIE, by this Indictment, accuses the defendants, RONNIE DUPREE, DION ANDERSON, ANTWAIN JACKSON, KENNETH PRINGLE, DEVAN HUNTINGTON, SABRINA LEEPER and DAVID VAUGHN, of the crime of CONSPIRACY IN THE SECOND DEGREE, in violation of Section 105.15 of the Penal Law of the State of New York, committed as follows:

The defendants, in Erie County, Niagara County, Chautauqua County, and elsewhere in and outside the State of New York, from on or before January 23, 2024, through on or about November 13, 2024, with intent that conduct constituting the crimes of Criminal Possession of a Controlled Substance in the First Degree, Criminal Possession of a Controlled Substance in the Second Degree, Criminal Sale of a Controlled Substance in the First Degree, and/or Criminal Sale of a Controlled Substance in the Second Degree, said crimes being Class A felonies, be committed, did knowingly and intentionally agree with each other and with others, known and unknown, to

engage in and cause the performance of such conduct as would constitute any one or more of the above-mentioned class A felonies.

### **PREAMBLE**

It was the purpose of this conspiracy to possess controlled substances in amounts of two ounces or more, and to sell controlled substances in amounts of one-half ounce or more in Erie County, Niagara County, Chautauqua County, and elsewhere in and outside the State of New York.

It was the role of RONNIE DUPREE to procure controlled substances from DION ANDERSON, ANTWAIN JACKSON, KENNETH PRINGLE, and others for redistribution to KENNETH PRINGLE and others.

It was the role of DION ANDERSON to supply RONNIE DUPREE, DAVID VAUGHN and others with controlled substances to sell.

It was the role of ANTWAIN JACKSON to supply RONNIE DUPREE, DEVAN HUNTINGTON, SABRINA LEEPER and others with controlled substances to sell.

It was the role of KENNETH PRINGLE to procure controlled substances from RONNIE DUPREE and others for redistribution to others and/or to supply RONNIE DUPREE and others with controlled substances to sell.

It was the role of DEVAN HUNTINGTON to procure controlled substances from ANTWAIN JACKSON and SABRINA LEEPER for redistribution to others.

It was the role of SABRINA LEEPER to procure controlled substances from ANTWAIN JACKSON for redistribution to DEVAN HUNTINGTON and others.

It was the role of DAVID VAUGHN to procure controlled substances from DION ANDERSON for redistribution to others.

It was also part of this conspiracy for members of the conspiracy to communicate with each other and others over cellular telephones, using codes and speaking in a guarded, cryptic manner.

### **OVERT ACTS**

In furtherance of the conspiracy and to affect the objects thereof, from on or about and between January 23, 2024, through on or about November 13, 2024, the following overt acts, among others, were committed:

- 1. On or about January 23, 2024, RONNIE DUPREE sold two ounces or more of cocaine to a person known to the Grand Jury in Erie County.
- 2. On or about July 24, 2024, KENNETH PRINGLE sold cocaine and fentanyl to RONNIE DUPREE in Niagara County.
- 3. On or about August 13, 2024, in a series of coded, guarded and/or cryptic telephone conversations, RONNIE DUPREE and KENNETH PRINGLE discussed the price of a quantity of cocaine that DION ANDERSON had available for purchase.
- 4. On or about August 31, 2024, in a series of coded, guarded and/or cryptic telephonic communications, DEVAN HUNTINGTON ordered a "half one" of "kreme", referring to a quantity of methamphetamine, from ANTWAIN JACKSON.
- 5. On or about August 31, 2024, in a series of coded, guarded and/or cryptic telephonic communications with SABRINA LEEPER, ANTWAIN JACKSON arranged to have LEEPER supply DEVAN HUNTINGTON with a quantity of methamphetamine in Chautauqua County.
- 6. On or about and between September 1, 2024, through on or about September 2, 2024, in a series of coded, guarded and/or cryptic telephonic communications with ANTWAIN JACKSON, DEVAN HUNTINGTON indicated that he would be sending JACKSON the money HUNTINGTON owed for methamphetamine JACKSON had previously supplied to HUNTINGTON.
- 7. On or about September 3, 2024, in a series of coded, guarded and/or telephonic communications with ANTWAIN JACKSON, SABRINA LEEPER apprised JACKSON of her

efforts to meet with DEVAN HUNTINGTON, so she could supply HUNTINGTON with the methamphetamine HUNTINGTON had previously ordered from JACKSON.

- 8. On or about September 4, 2024, RONNIE DUPREE, ANTWAIN JACKSON, and KENNETH PRINGLE met at Kingsley Park in the city of Buffalo in furtherance of their controlled substance trafficking activities.
- 9. On or about September 4, 2024, DION ANDERSON delivered cocaine to a person waiting outside RONNIE DUPREE'S residence in the city of Buffalo.
- 10. On or about September 17, 2024, DION ANDERSON sold two ounces or more of cocaine to RONNIE DUPREE at ANDERSON'S residence in the city of Buffalo.
- 11. On or about September 25, 2024, DEVAN HUNTINGTON traveled to Bryant Street in the city of Buffalo to procure methamphetamine from ANTWAIN JACKSON.
- 12. On or about October 3, 2024, ANTWAIN JACKSON and SABRINA LEEPER met in a parking lot in Chautauqua County in furtherance of their controlled substance trafficking activities.
- 13. On or about October 18, 2024, in a series of coded, guarded and/or telephonic communications with KENNETH PRINGLE, RONNIE DUPREE asked PRINGLE to supply him with "soft", referring to a quantity of powder cocaine, and they arranged to meet to conduct the transaction.
- 14. On or about October 21, 2024, in a series of coded, guarded and/or telephonic communications, DAVID VAUGHN and DION ANDERSON discussed the price of a "bottle", referring to a quantity of cocaine.
- 15. On or about October 21, 2024, DAVID VAUGHN traveled to DION ANDERSON'S residence in the city of Buffalo to procure cocaine from ANDERSON.

- 16. On or about October 22, 2024, KENNETH PRINGLE traveled to RONNIE DUPREE'S residence to procure cocaine form DUPREE.
- 17. On or about November 13, 2024, DION ANDERSON possessed more than eight ounces of cocaine at his residence in the city of Buffalo.

### **SECOND COUNT**

AND THE GRAND JURY OF THE COUNTY OF ERIE, by this indictment, further accuses the defendant, RONNIE DUPREE, of the crime of **CRIMINAL SALE OF A CONTROLLED SUBSTANCE IN THE FIRST DEGREE**, in violation of Section 220.43(1) of the Penal Law of the State of New York, in that he, the said RONNIE DUPREE, on or about the 23<sup>rd</sup> day of January 2024, in Erie County, knowingly and unlawfully sold one or more preparations, compounds, mixtures or substances containing a narcotic drug, to wit: cocaine, and said preparations, compounds, mixtures or substances were of an aggregate weight of two ounces or more.

# **THIRD COUNT**

AND THE GRAND JURY OF THE COUNTY OF ERIE, by this indictment, further accuses the defendant, RONNIE DUPREE, of the crime of **CRIMINAL POSSESSION OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE**, in violation of Section 220.16(1) of the Penal Law of the State of New York, in that he, the said RONNIE DUPREE, on or about the 23<sup>rd</sup> day of January 2024, in Erie County, knowingly and unlawfully possessed a narcotic drug, to wit: cocaine, with the intent to sell it.

### **FOURTH COUNT**
